 - (1) This number represents the PepsiCo Equity Performance units ("PEPunits") granted to the reporting person as a portion of his compensation from PepsiCo, Inc. These PEPunits will become vested on March 1, 2018 subject to absolute stock price performance and relative total shareholder return consistent with a pre-established payout scale determined for the three-year performance period and approved by the Compensation Committee. The reporting person may receive a number of shares of PepsiCo Common Stock from 0% to 175% of the PEPunits granted, depending on the level of performance achieved.
 - (2) Reflects the number of shares held under the reporting person's account in the PepsiCo Savings Plan as of February 27, 2015.
 - (3) These phantom units are held under the PepsiCo Executive Income Deferral Program and convert to shares of PepsiCo Common Stock on a one-for-one basis.
 - (4) This amount relates to dividends credited to the reporting person's phantom stock account on various dates between July 1, 2014 and March 1, 2015 pursuant to PepsiCo's Executive Income Deferral Program, at prices ranging from \$93.09 to \$95.74.
