(1) This Form 3 is being filed in connection with the SEC's declaration of effectiveness of the Registration Statement on Form 10 of Varex Imaging Corporation ("SpinCo"), which describes the planned separation of SpinCo from Varian Medical Systems, Inc. ("Parent").

Pursuant to SpinCo's Certificate of Incorporation (as amended), effective as of 6:00 p.m., Pacific time, on the date set by resolution of the Board of Directors of Parent as the record date for distribution of shares of SpinCo's Common Stock to holders of Parent common shares (such time, the "Effective Time"), the 100 shares of SpinCo's Common Stock held by Parent prior to the Effective Time shall, automatically by operation of law and without any further action on the part of SpinCo or Parent, be subdivided and converted into a number of shares of validly issued, fully paid and non-assessable shares of SpinCo's Common Stock equal to the number of common shares, par value \$1.00, of Parent, issued and outstanding as of the Effective Time, divided by two hundred fifty (250).
