- (1) These shares of common stock were acquired by the Reporting Person under the EMCORE Corporation 2012 Equity Incentive Plan. 1,894 shares of common stock were awarded to the Reporting Person for his service as Co-Chairman of the Board, and 9,469 shares of common stock were awarded to the Reporting Person for additional workload the Reporting Person took on in 2014 in connection with a strategy review process undertaken by the Issuer.
- (3) These phantom share credits were credited to the Reporting Person's account because the Reporting Person elected to defer receipt of shares of common stock that the Reporting Person was entitled to receive for service as a non-employee director pursuant to the EMCORE Corporation 2007 Directors' Stock Award Plan.
