These are deferred common stock units acquired pursuant to the Company's 2004 Stock Incentive Plan and the Deferred Compensation Plan for Non-Employee Directors. The deferred common stock units are converted into shares of Company common stock on a one-for-one basis upon distribution. Distribution of shares of common stock occurs six months after the director's service on the Board terminates, or upon another date or dates designated by the director pursuant to the Company's Deferred Compensation Plan for Non-Employee Directors.

(1) Includes deferred common stock units, including those being currently reported, granted under the Company's 2004 Stock Incentive Plan and its Deferred Compensation Plan for Non-Employee Directors. Also includes 16.18 deferred common stock units acquired on March 31, 2005 through dividend reinvestment features under these plans.
