### **GOLL4 Shares Included in IBrX-50 Index**

**São Paulo, May 2, 2006** GOL Linhas Aéreas Inteligentes (Bovespa: GOLL4 and NYSE: GOL), Brazil's low-cost, low-fare airline, announced that GOLL4 shares were included in the Sao Paulo Stock Exchange's (Bovespa) IBrX-50 Index. The IBrX-50 measures the total return of a select portfolio of the 50 most actively traded stocks on the Sao Paulo Stock Exchange, in terms of liquidity.

To be included in the index, the Company had to meet several requirements, including being among the top 50 most traded stocks in the 12 months prior to evaluation, and must also have been traded in at least 80% of the exchange sessions in the 12 months prior to the formation of the portfolio.

GOL's inclusion in the IBrX-50 Index demonstrates the high liquidity of the Company's shares, which has steadily increased since our initial listing on the Bovespa in June 2004, says Richard Lark, Chief Financial Officer of GOL.
