**Item 8.01 Other Events.**

On October 14, 2014, General Mills, Inc. (the "Company") agreed to sell \$500,000,000 principal amount of its 1.400% Notes due 2017 and \$500,000,000 principal amount of its 2.200% Notes due 2019 (collectively, the "Notes") pursuant to the Underwriting Agreement, dated October 14, 2014 (the "Underwriting Agreement"), among the Company, Barclays Capital Inc., Merrill Lynch, Pierce, Fenner & Smith Incorporated and Credit Suisse Securities (USA) LLC, as representatives of the several underwriters listed on Schedule II of the Underwriting Agreement. The Notes will be issued pursuant to that certain Indenture, dated as of February 1, 1996 (as amended, the "Indenture"), between the Company and U.S. Bank National Association, as Trustee, and the Officers' Certificates and Authentication Orders, dated October 21, 2014 (collectively, the "Officers' Certificates"), pursuant to Sections 201, 301 and 303 of the Indenture. The offer and sale of the Notes has been registered under the Securities Act of 1933, as amended, by Registration Statement on Form S-3 (No. 333-179621). The sale of the Notes is expected to close on October 21, 2014.

The purpose of this Current Report is to file with the Securities and Exchange Commission the Underwriting Agreement, the Officers' Certificates and the opinion of Dorsey & Whitney LLP with respect to the validity of the Notes.
