(1) On February 17, 2015, the reporting person was granted 5,778 Restricted Stock Units for no monetary consideration. The Restricted Stock Units convert into (i) 3,467 common shares and (ii) cash equal to the market value of 2,311 common shares (measured at the date of vesting) upon the vesting of such Restricted Stock Units.

(2) Includes 436 common shares acquired on June 30, 2015 pursuant to the Company's Amended and Restated 2008 Employee Share Purchase Plan.

(3) The fair market value of the cash portion was determined using the daily volume-weighted average sales price of the common shares for the five consecutive trading days up to and including February 17, 2016.

(4) Exclusively represents shares withheld by the Company with respect to the payment of withholding tax liability incurred upon the vesting of Restricted Stock Units.

(5) On February 18, 2014, the reporting person was granted 6,660 Restricted Stock Units for no monetary consideration.
