- (1) These common shares were acquired upon the vesting and settlement of certain restricted stock units.

Each restricted stock unit represents a contingent right to receive one share of TFS Financial Corporation common stock. Restricted stock units are entitled to dividend equivalent rights in the form of a cash payment in the amount of any cash dividend paid per share of common stock.
- (5) The reporting person received a grant of 5,800 Restricted Stock Units ("RSU's") on December 28, 2012. These RSU's vest in three equal annual installments beginning December 15, 2013.
- (6) The reporting person received a grant of 49,200 stock options on December 17, 2015. These stock options vest in three equal annual installments beginning December 10, 2016.
- (7) The reporting person received a grant of 4,500 Restricted Stock Units ("RSUs") on December 17, 2015. These RSUs vest in three equal annual installments beginning December 10, 2016.
