Each Common Unit acquired upon the conversion of an LTIP Unit is redeemable by the holder for shares of common stock of the Issuer on a one-for-one basis. LTIP units are generally not convertible until two years from the date of the grant.

(5) LTIP Units converted into Common Units of limited partnership interest in DRLP according to terms described above.

(6) LTIP Units vest in three equal installments beginning on February 10, 2017 and have no expiration date.

LTIP Units awarded in lieu of performance share plan units and upon meeting the performance-based conditions, pursuant to Rule

(7) 16b-3(d) of Section 16b of the Securities Exchange Act of 1934. LTIP Units are awarded according to the terms described in footnote 4 and have no expiration date.

(8) Represents Common Units of Duke Realty Limited Partnership (DRLP). Each Common Unit is redeemable by the holder for shares of common stock of the Issuer on a one-for-one basis. Common Units have no expiration date.
