(1) On 10/15/2007, Reporting Person was awarded restricted stock units (RSUs). Each RSU represents a contingent right to receive one (1) share of VeriSign common stock once vested. Twenty-five percent (25%) of the grant vests over four years on the anniversary of the date of grant, subject to necessary withholding for applicable taxes.

(2) On 10/15/2007, Reporting Person was awarded performance-based restricted stock units (performance-based RSUs). Each performance-based RSU represents a contingent right to receive one (1) share of VeriSign common stock once vested. If certain performance criterion is achieved, one hundred percent (100%) of the grant vests on the third anniversary of the date of grant, subject to applicable taxes upon delivery. If certain performance criterion is not achieved, fifty percent (50%) of the grant vests on the fourth anniversary of the date of grant, subject to applicable taxes upon delivery, and the remaining fifty percent (50%) of the grant is forfeited.

(3) Twenty-five percent (25%) of the total options granted vest and become exercisable one year after the date of grant and thereafter with respect to 6.25% of the shares each quarter until fully vested.
