Each RSU represents a contingent right to receive one share of Class A Common Stock. Of the 7,143 RSUs, 3,572 RSUs will vest on June 3, 2015 and 3,571 RSUs will vest on June 3, 2016, provided that the reporting person continues to serve as a member of the Board of Directors on such dates.
- (2) Includes (i) 7,599 RSUs granted on December 17, 2012, which will vest on December 17, 2014; and (ii) 15,198 RSUs granted on June 4, 2013, of which 7,599 RSUs will vest on June 4, 2014 and 7,599 RSUs will vest on June 4, 2015, provided that the reporting person continues to serve as a member of the Board of Directors on such dates.
