CCMP Capital is, therefore, deemed to indirectly beneficially own such 9,369 shares. Mr. Walsh disclaims beneficial ownership of these 9,369 shares to the extent it exceeds his pecuniary interest therein and the inclusion of the shares in this report shall not be deemed to be an admission of beneficial ownership of the reported shares for the purposes of Section 16 or otherwise.
