Each Basket Component is a price return index. The EURO STOXX 50 <sup>®</sup> Index will be given an initial weight of 40.00%, each of the FTSE <sup>®</sup> 100 Index and the Nikkei Stock Average Index will be given an initial weight of 20.00%, each of the Swiss Market Index and the S&P/ASX 200 Index will be given an initial weight of 7.50% and the Hang Seng <sup>®</sup> Index will be given an initial weight of 7.50%.
<b>Payout Profile at Maturity</b>	If the Market Measure is flat or increases up to the Step Up Value, a return equal to the Step Up Payment  If the Market Measure increases above the Step Up Value, a return equal to the percentage increase in the Market Measure
<b>Step Up Value</b>	1-to-1 downside exposure to decreases in the Market Measure , with 100% of your principal at risk [112.00% to 118.00%] of the Starting Value, to be determined on the pricing date
