- (1) There was a 10% stock dividend on September 30, 2016, for which Mr. Maricondo received additional shares.
- (2) 3,032 stock options were granted on 1/25/07, which vest 1/3 each year commencing 1/25/08; 1/25/09 and 1/25/10 and expire on 1/25/17. Mr. Maricondo received 843 shares of common stock through a "net-out" with the Company on 12/8/16.
- (3) 17,820 stock options were granted to Mr. Maricondo of which 13,420 are currently exercisable.
- (4) Mr. Maricondo exercised 3,032 stock options at \$11.48 through a "net out" with the Company based on the stock price of \$15.90 resulting in the issuance of 843 shares on common stock.
