- (1) On January 21, 2015, the compensation committee of the Issuer approved the grant of restricted stock to the reporting person. Represents shares of restricted stock that will vest as follows: 52,112 shares will vest in three equal annual installments beginning on January 21, 2016, and 78,168 shares will vest upon achievement of specified performance targets at the end of a three-year measuring period ending on December 28, 2017.
