On May 17, 2018, a subsidiary of Marriott International, Inc. (“Marriott”) sold Le Centre Sheraton Montreal Hotel to a private investor for approximately C\$92 million. Marriott retained a long-term management agreement for the 825-room property located in downtown Montreal in Quebec, Canada. The Hotel will undergo a comprehensive renovation including the guest rooms, lobby, meeting space, and ballroom, as well as other public areas.
