Mr. Spencer is retiring from the Board because he is not eligible under WesBanco's Bylaws to stand for re-election due to the Company's mandatory retirement age provision for directors, and not as a result of any disagreement with WesBanco. Mr. Spencer's service on the Board began in 2012 as a result of WesBanco's acquisition of Fidelity Bancorp, Inc.
