[1] The title of the securities underlying the American Depository Shares is Common Stock, par value (Won)5,000 per

direct the vote of such securities.

[3] One or more of the investment management contracts that relates to these securities provides that the applicable FRI

affiliate share investment power over the securities held in the client's account with another unaffiliated entity. The

issuer's securities held in any such account are less than 5% of the outstanding shares of the class. In addition, FRI does

not believe that any such contract causes any such client or unaffiliated entity to be part of a group with FRI or any FRI

affiliate within the meaning of Rule 13d-5 under the Act.
