On October 27, 2017 and November 9, 2017, Tenet Healthcare Corporation (the “Company”) filed Current Reports on Form 8-K disclosing under Item 5.02 that James L. Bierman, Richard W. Fisher and Richard J. Mark had each been named to the Board of Directors (the “Board”) of the Company. At the time of the filings, Messrs.
