Restated Articles of Incorporation on February 22, 2006 with the California Secretary of State. The amendment will become effective on March 2, 2006. Pursuant to such amendment, (i) as of the close of business on March 2, 2006, each share of common stock outstanding will be split into two shares of common stock, (ii) the par value of each share of common stock will be decreased from \$1.042 to \$0.521, and (iii) the aggregate number of authorized shares of common stock will be increased from 18,000,000 to 36,000,000. Stock certificates representing the additional shares of common stock will be mailed or delivered to stockholders on or about March 16, 2006, by the Company's transfer agent, American Stock Transfer and Trust Company.
