- (2) Amendment No. 1 to the Merger Agreement, dated as of August 15, 2014, Merger Sub merged with and into the Company. The merger was consummated on September 12, 2014. The Company was the surviving corporation and, as a result of the merger, became a wholly-owned subsidiary of Cobham.

Each share of the common stock, par value \$0.01 per share of the Company issued and outstanding immediately prior to the effective

- (3) time of the merger was cancelled and automatically converted into the right to receive \$10.50 in cash, without interest, and less any applicable withholding taxes.
