NORTH LIBERTY, IOWA - March 9, 2009 - Heartland Express, Inc. (Nasdaq: HTLD) The Board of Directors of Heartland Express, Inc. announced today the declaration of a regular quarterly cash dividend. The \$0.02 per share dividend will be paid on April 2, 2009 to shareholders of record at the close of business on March 20, 2009. A total of approximately \$1.8 million will be paid on the Company's 91.2 million outstanding shares of common stock.
