Intertape Polymer Group Announces Renewal of Normal Course Issuer Bid

MONTREAL, QUEBEC and SARASOTA, FLORIDA - July 18, 2018 - Intertape Polymer Group Inc. (TSX:ITP) (the "Company") is pleased to announce that the Toronto Stock Exchange ("TSX") has approved the renewal of the Company's normal course issuer bid ("NCIB"). Under the renewed NCIB, the Company will be entitled to repurchase for cancellation up to 4,000,000 common shares, representing 7.14% of the Company's "public float" as of July 9, 2018, over a twelve-month period starting on July 23, 2018 and ending on July 22, 2019. The purchases by the Company will be effected through the facilities of the TSX and on other alternative trading systems in Canada, and will be made at the market price of the shares at the time of the purchase. There were 58,817,410 common shares of the Company issued and outstanding as of July 9, 2018, of which 56,044,745 shares constituted the "public float". During the most recently completed six months, the average daily trading volume for the common shares of the Company on the TSX was 152,366 shares. Consequently, under the policies of the TSX, the Company will have the right to repurchase during any one trading day a maximum of 38,091 common shares, representing 25% of the average daily trading volume. In addition, the Company may make, once per calendar week, a block purchase (as such term is defined in the TSX Company Manual) of common shares not directly or indirectly owned by insiders of the Company, in accordance with the policies of the TSX.

The Company intends to acquire the common shares because it believes that the repurchase of common shares at certain market prices is beneficial to the Company and its shareholders. The Company intends to make any purchases on an opportunistic basis, taking share price and other considerations into account.

Any purchases made pursuant to the NCIB will be made in accordance with the requirements of the TSX. Except for exempt offers, the Company will make no purchases of common shares other than open market purchases during the period of the NCIB.

Under the Company's current NCIB, which expires today, the Company is authorized to purchase up to 4,000,000 shares. During the twelve month period ended July 9, 2018, the Issuer purchased 487,300 common shares under its current NCIB at a weighted average price of CDN \$18.87 through open market purchases.
