- (1) On November 2, 2009, an aggregate of 163,044 shares of restricted stock vested pursuant to the terms of restricted stock awards made to Mr. Schreyer in his individual capacity by GLG Partners, Inc. ("GLG") under GLG's 2007 Long-Term Incentive Plan and 2007 Restricted Stock Plan. The shares of restricted stock vest in four equal installments on each of November 2, 2008, 2009, 2010 and 2011. On November 2, 2009, the second installment of an aggregate of 163,044 shares vested. Of the 163,044 aggregate shares that vested on November 2, 2009, an aggregate of 83,936 shares were withheld and transferred to GLG to cover Mr. Schreyer's individual tax withholding obligations with respect to the vested shares.
