Mr. Cohen controls each of Point72 Capital Advisors Inc. and EverPoint Asset Management. As of December 31, 2015, by reason of the provisions of Rule 13d-3 of the Securities Exchange Act of 1934, as amended, each of (i) Point72 Asset Management, Point72 Capital Advisors Inc. and Mr. Cohen may be deemed to beneficially own 2,111,876 Shares (constituting approximately 6.2% of the Shares outstanding); and (ii) EverPoint Asset Management and Mr. Cohen may be deemed to beneficially own 558,647 Shares (constituting approximately 1.6% of the Shares outstanding).
