(a) (b) As of December 31, 2004, Mr. Davis may be deemed to beneficially own (1) 2,843,676 shares or 8.8% of the Issuer's shares issued and outstanding as follows (i) 30,525 shares owned directly by Mr. Davis, (ii) 1,416,052 shares owned directly by Blair Investment, (iii) 663,446 shares owned by Engex, Inc. (2), (iv) 12,733 shares owned by an investment advisor whose principal is Mr. Davis, and (v) 720,870 shares owned by Rosalind Davidowitz, Mr. Davis' wife (3).

(c) Mr. Davis has sole power to vote or to direct the vote, to dispose or to direct the disposition of those shares owned by Blair Investment. Rosalind Davidowitz has sole power to dispose or to direct the disposition of those shares owned directly by her (4). Voting and dispositive decisions regarding shares owned by Engex are made by Mr. Davis as Chairman of the Board.
