The name of the issuer is MOBILITY ELECTRONICS, INC. (the "Company").

- (iv) Phillip Gross ("Mr. Gross"), as managing member of ACA, managing member of ACPGP, and general partner of ACP with respect to the shares of Common Stock directly owned by ACP; and
- (v) Robert Atchinson ("Mr. Atchinson"), as managing member of ACA, managing member of ACPGP, and general partner of ACP with respect to the shares of Common Stock directly owned by ACP.

The foregoing persons are hereinafter sometimes collectively referred to as the "Reporting Persons." Any disclosures herein with respect to persons other than the Reporting Persons are made on information and belief after making inquiry to the appropriate party.

By reason of the provisions of Rule 13d-3 of the Securities Exchange Act of 1934 (the "Act"), ACPGP and ACA may be deemed to own beneficially the shares owned by ACP.
