(collectively, the "Highbridge Funds") may be deemed to be the beneficial owner of the 2,759,904 shares of Common Stock issuable upon conversion of the 5.25% Convertible Senior Notes due 2019 held by the Highbridge Funds.

(b) Percent of class:

The percentages used herein and in the rest of this Schedule 13G are calculated based upon 51,629,593 shares of Common Stock reported to be outstanding as of February 26, 2014 in the Company's Quarterly Report on Form 10-Q for the quarterly period ended January 31, 2014 filed on March 3, 2014. Therefore, as of the date hereof, based on the Company's outstanding shares of Common Stock, Highbridge Capital Management, LLC may be deemed to beneficially own approximately 5.07% of the outstanding shares of Common Stock of the Company.
