**Item 1(a). NAME OF ISSUER**

The name of the issuer is Western Asset High Yield Defined Opportunity Fund Inc. (the "Company").

("SCMF II"), Saba Capital Leveraged Master Fund Ltd., ("SCLMF") and Saba Capital Partners (Cayman), L.P. ("SCP").<sup>2</sup>

The Reporting Persons have entered into a Joint Filing Agreement, dated May 9, 2014, a copy of which is filed with this Schedule 13G as Exhibit 1, pursuant to which the Reporting Persons have agreed to file this statement jointly in accordance with the provisions of Rule 13d-1(k)(1) under the Act.

The filing of this statement should not be construed as an admission that any of the forgoing persons or the Reporting Persons is, for the purposes of Section 13 of the Act, the beneficial owner of the shares of Common Stock reported herein.
