DIANA SHIPPING INC. ANNOUNCES LONG TERM TIME CHARTER CONTRACT FOR MV CORONIS

ATHENS, GREECE, January 9, 2007 - Diana Shipping Inc. (NYSE: DSX), a global shipping company specializing in the transportation of dry bulk cargoes, today announced that it has entered into a time charter contract with Bottiglieri di Navigazione for its Panamax dry bulk carrier, the MV Coronis, for a minimum of 23 to a maximum of 25 months at a gross daily charter hire rate of \$27,500. The charter is expected to commence on February 27, 2007.

This employment is expected to generate approximately US\$18.5 million of gross revenues during the minimum 23 month period of the charter.

The MV Coronis is a 74,381 dwt Panamax dry bulk carrier built in 2006.

Diana Shipping Inc. (NYSE: DSX) is a global provider of shipping transportation services. The Company specializes in transporting dry bulk cargoes, including such commodities as iron ore, coal, grain and other materials along worldwide shipping routes.
