As of the close of business on November 22, 2011, (i) BVF beneficially owned 725,036 shares of Common Stock, (ii) BVF2 beneficially owned 444,151 shares of Common Stock, (iii) BVLLC beneficially owned 2,068,326 shares of Common Stock and (iv) ILL10 beneficially owned 238,531 shares of Common Stock.

Partners, as the general partner of BVF and BVF2, the manager of BVLLC and the investment adviser of ILL10, may be deemed to beneficially own the 3,476,044 shares of Common Stock beneficially owned in the aggregate by BVF, BVF2, BVLLC and ILL10.

As of the close of business on November 22, 2011, (i) BVF beneficially owned approximately 3.7% of the outstanding shares of Common Stock, (ii) BVF2 beneficially owned approximately 2.3% of the outstanding shares of Common Stock, (iii) BVLLC beneficially owned approximately 10.5% of the outstanding shares of Common Stock, (iv) ILL10 beneficially owned approximately 1.2% of the outstanding shares of Common Stock and (v) each of Partners, BVF Inc. and Mr. Lampert may be deemed to beneficially own approximately 17.7% of the outstanding shares of Common Stock.
