On May 15, 2013, Great Southern Bancorp, Inc. ("Bancorp") held its Annual Meeting of Stockholders. Of the 13,611,056 shares entitled to vote at the meeting (without reduction for the 10% voting limitation in Bancorp's charter), 12,212,481 were present at the meeting in person or by proxy. The results of the meeting, which exclude 774,329 shares beneficially owned in excess of the 10% voting limitation by the persons believed by Bancorp to be subject to that limitation, are as follows:
