Item 1. Security and Issuer

This statement constitutes Amendment No. 4 to the Schedule 13D relating to the shares of Common Stock, \$1 par value ("Shares"), issued by TEGNA Inc. (formerly known as Gannett Co., Inc.) (the "Issuer"), and hereby amends the Schedule 13D filed with the Securities and Exchange Commission (the "SEC") on August 14, 2014, as amended by Amendment No. 1 to the Schedule 13D, filed with the SEC on September 12, 2014, Amendment No. 2 to the Schedule 13D, filed with the SEC on January 22, 2015, and Amendment No. 3 to the Schedule 13D, filed with the SEC on March 2, 2015, to voluntarily furnish the additional information set forth herein. All capitalized terms contained herein but not otherwise defined shall have the meanings ascribed to such terms in the Schedule 13D.

On June 29, 2015, the Issuer completed the previously announced separation of its business into two independent publicly-traded companies via the transfer of the Issuer's Publishing business to Gannett Co., Inc. (formerly known as Gannett SpinCo, Inc.) ("SpinCo") and the distribution of 98.5% of the outstanding shares of SpinCo common stock to the Issuer's stockholders (the "Distribution"). As a result of the Distribution, the Issuer changed its name from Gannett Co., Inc. to TEGNA Inc. and the Shares now trade under the symbol "TGNA" on the New York Stock Exchange. The outstanding shares of SpinCo common stock now trade under the symbol "GCI" on the New York Stock Exchange.
