(1) On February 25, 2008, the Reporting Person was granted 2,990 (target) performance-based restricted stock units ("PBRUs") pursuant to the Issuer's 2006 Long Term Incentive Plan. On February 28, 2011, the Compensation Committee determined that the level of performance achieved entitled holders of the PBRUs to 54% of their target award. Accordingly, on February 28, 2011, the PBRUs vested and converted into the number of shares indicated on this Form 4.
