As of December 31, 2003, Select and Select Offshore are the beneficial owners of 1,171,213 shares of Common Stock of Franklin Electric Co., Inc. ("Common Stock"), for a total beneficial ownership of 10.75% of the outstanding shares of Common Stock. As the President and controlling shareholder of Select and Manager of Select Offshore, Loening has the power to vote and to direct the voting of and the power to dispose and direct the disposition of the 1,717,213 shares of Common Stock owned by Select and Select Offshore. Accordingly, Loening may be deemed to be the beneficial owner of 1,171,213 shares of Common Stock, or 10.75% of the outstanding shares of Common Stock.
