TELECOM ITALIA: NEW STERLING BOND OFFERING FOR INSTITUTIONAL INVESTORS

The issue falls under the Company's programme to refinance debt reaching maturity, ensuring financing cost efficiencies through currency diversification and investor base extension

Milan, June 15, 2004 - Telecom Italia S.p.A. has mandated ABN AMRO, HSBC, Lehman Brothers and Royal Bank of Scotland as Lead Arrangers and Bookrunners of a benchmark Sterling-denominated issue, consisting of a fifteen-year maturity fixed-rate bond.

The bonds of an aggregate total to be determined according to investor demand shall be issued under Telecom Italia's Euro Medium Term Note (EMTN) Programme, which allows for the issuance of bonds in different tranches and in different currencies on the Eurobond market by Telecom Italia and/or Telecom Italia Finance, guaranteed by Telecom Italia, for a maximum of up to 10 billion euros.

The purpose of the issue is to refinance outstanding debt approaching maturity, and to ensure financing cost efficiencies through currency diversification and extension of the investor base.

The securities referred to in this press release have not been and will not be registered under the U.S. Securities Act of 1933 and may not be offered or sold in the United States absent registration or an applicable exemption from registration requirements.

- the impact of the slowdown in Latin American economies and the slow recovery of economies generally on the international business of the Telecom Italia Group focused on Latin America and on its foreign investments and capital

- the continuing impact of rapid changes in technologies;
- the impact of political and economic developments in Italy and other countries in which the Telecom Italia Group operates;
