CGII does not have investment power or voting power over any of the securities reported herein. However, by virtue of Rule 13d-3 under the Act, CGII may be deemed to "beneficially own" 41,070,430 shares or 2.8% of the 1,456,866,319 shares of Ordinary Shares, including American Depositary Shares, believed to be outstanding.
