- If the final underlying value of the worst performing underlying is **greater than** its initial underlying value: $\$1,000 +$ the return amount, subject to the maximum return at maturity
- If the final underlying value of the worst performing underlying is **less than or equal to** its initial underlying value but **greater than or equal to** its final barrier value: $\$1,000$
- If the final underlying value of the worst performing underlying is **less than** its final barrier value: $\$1,000 + (\$1,000 \times$ the underlying return of the worst performing underlying)

If the final underlying value of the worst performing underlying is less than its final barrier value, you will receive significantly less than the stated principal amount of your securities, and possibly nothing, at maturity. Key Definitions

Worst performing underlying: The underlying with the lowest underlying return

Selected Risk Considerations
