- (3) Applicable provisions of the governing instrument pursuant to which the securities are to be redeemed: The Preferred Shares are to be redeemed pursuant to Section 11.4(a)(i) of Article 11 of the Amended and Restated Bylaws of the Fund.
- (4) If less than all the outstanding securities of a class or series are to be called or redeemed, the principal amount or number of shares and the basis upon which the securities to be called or redeemed are to be selected:

The Fund is partially redeeming its Preferred Shares on a pro rata basis by series. The Depository Trust Company (DTC), holder of record of the Preferred Shares, determines how the redemption will be allocated among each participant broker-dealer account that holds Preferred Shares and each participant broker-dealer determines how to allocate each redemption among the beneficial holders of the Preferred Shares held by it. The procedures used by participant broker-dealers to allocate redeemed Preferred Shares among their clients may differ from each other and from the procedures used by DTC.
