**EXPLANATORY STATEMENT**

This Post-Effective Amendment No. 1 to Registration Statement on Form S-8, Registration No. 333-69012 (the Registration Statement ), is being filed to deregister certain shares of common stock, par value \$.01 per share (the Shares ), of Delphi Corporation (the Registrant ) that were registered for issuance pursuant to the Delphi Corporation Stock Incentive Plan (the Plan ). On October 6, 2009, the Registrant 's plan of reorganization, as confirmed by the United States Bankruptcy Court for the Southern District of New York on July 30, 2009, became effective and all outstanding Shares were cancelled. At such time, the Registrant emerged from bankruptcy as DPH Holdings Corp., a Delaware corporation. The Registration Statement registered 24,000,000 Shares pursuant to the Plan and the Registration Statement is hereby amended to deregister the remaining unissued Shares.
