This Post-Effective Amendment No. 1 relates to the Registration Statement on Form S-8 (File No. 333-56356 (the Registration Statement) of ADC Telecommunications, Inc. (the Company), which was filed with the U.S. Securities and Exchange Commission on February 28, 2001.
