(e) On May 7, 2007, Origen Financial, Inc. ( Origen ), and certain of its directors, executive officers, including Ronald A. Klein, W. Anderson Geater, Jr., J. Peter Scherer, Mark W. Landschulz and Benton E. Sergi, and other employees agreed to extend the vesting dates for previously granted shares of restricted stock. The vesting date for shares scheduled to vest on May 8, 2007 was extended to May 11, 2007 and the vesting dates for shares scheduled to vest on May 8<sup>th</sup> of 2008, 2009, 2010 and 2011 were extended to May 15<sup>th</sup> of such years. The vesting dates were extended in order to avoid potential concerns related to the timing of the vesting of shares of restricted stock and the release of Origen s first quarter earnings.
