Planet Technologies, Inc. (the Company) is filing this Form 12b-25 because it needs additional time to file its Quarterly Report on Form 10-QSB for the quarter ended September 30, 2005, which was due on November 14, 2005. As previously reported on its 8-K filed on August 12, 2005, the Company shareholders approved the Agreement and Plan of Merger with Allergy Control Products, Inc. (ACP) at its Annual Shareholder Meeting on August 11, 2005, wherein ACP became a wholly owned subsidiary of the Company, under the name of Allergy Control Products, Inc. (New ACP). As a result of the merger, the Company is required to file pro forma and consolidated financials which have taken more time to complete than anticipated. In addition, it cannot file its Third Quarter Form 10-QSB until JH Cohn, LLP, its independent registered public accounting firm, completes its limited review of the Third Quarter Form 10-QSB. The Company will file its 10-QSB on or before the fifth day following the prescribed due date.
