The options exercised on March 8, 2004 were granted on December 1, 1999 and December 6, 2000. The grant on December 1, 1999 was 150,000 options of which 50,000 were previously exercised. The grant on December 6, 2000 was 200,000 options and this is the first option exercise pursuant to this grant.
