The securities reported include all shares held of record by the Trustee. The Trustee follows the directions of the Employer, Patterson Companies, Inc. (the "Employer"), or other parties designated in the trust agreement between the Employer and the Trustee, with respect to voting and disposition of shares. The Trustee, however, is subject to fiduciary duties under ERISA. The Trustee disclaims beneficial ownership of the shares of common stock that are the subject of this Schedule 13G.
- (b) The 14,714,840 shares of common stock represent 14.91% of the Issuer's outstanding shares of common stock. The percent of class is based on shares outstanding as of December 31, 2015, as provided by the Issuer.
