- These units are awarded pursuant to the Restoration Supplemental Retirement Plan ("Restoration Plan"). Generally, units under this plan
- (5) shall be paid out following termination of employment or later as per the terms of the plan document. Each unit is equal to one share of AES Common stock and units under the Restoration Plan are 100% vested upon award.
