ITEM 4.01 CHANGES IN REGISTRANT'S CERTIFYING ACCOUNTANT

Effective March 13, 2008, Kabani & Company, Inc. ("Kabani") resigned as the independent auditor of Material Technologies, Inc. (the "Company"). The decision to accept Kabani's resignation was approved by the Company's Board of Directors.

Kabani was engaged by the Company on November 5, 2007. Kabani's services for the Company were limited to a review of the Company's Quarterly Report on Form 10-QSB for the quarter ended September 30, 2007. During their engagement, through March 13, 2008, there were no disagreements with Kabani on any matter of accounting principles or practices, financial statement disclosure, or auditing scope or procedure which, if not resolved to the satisfaction of Kabani would have caused Kabani to make reference to the matter in their reports.

Effective March 13, 2008, the Company's Board of Directors appointed Gruber & Co. LLC ("Gruber") as its new registered independent certified public accounting firm. Gruber is located at 572 Shasta Drive, Encinitas, California 92024.
