- (1) The holder settled all of his 12,467 vested phantom units for RGP common units on the date of vesting.
On May 16, 2012, in connection with Mr. Jolas's resignation from the Partnership, Regency GP LLC, the General Partner of Regency Energy Partners LP, accelerated the vesting requirement at the 100% target level with respect to 10,200 performance-based phantom units granted to Mr. Jolas on May 7, 2010. On May 16, 2012, Regency GP LLC also accelerated the vesting requirement with respect to 2,267 time-based phantom units granted to Mr. Jolas on May 7, 2010, which grant was previously disclosed on a Form 4 filed with the Securities and Exchange Commission on May 11, 2010.
- (3) Each Phantom Unit is the economic equivalent of one common unit representing a limited partner interest in Regency Energy Partners LP.
