- (1) Vesting of restricted stock units ("RSUs") granted to the Reporting Person on February 12, 2014.

All of the shares reported as disposed of on this row were relinquished by the Reporting Person and cancelled by the Issuer in exchange for the Issuer's agreement to pay federal and state tax withholding obligations of the Reporting Person resulting from the vesting of RSUs.
- (3) The price per share was based on the fair market value of the Issuer's common stock on the vesting and release date.
- (4) The sales reported on this Form 4 were effected pursuant to a Rule 10b5-1 trading plan adopted by the Reporting Person on March 10, 2015.

Shares of the Issuer's common stock will be delivered to the Reporting Person upon vesting.
