Item 1.01 - Entry into a Material Definitive Agreement

As previously reported on a Form 8-K, dated July 1, 2007 (the "July 1 Form 8-K"), of Consolidated Communications Holdings, Inc. (the "Company"), the Company reported that, on July 1, 2007, the Company and North Pittsburgh Systems, Inc. ("North Pittsburgh") entered into an Agreement and Plan of Merger (the "Merger Agreement").

A copy of the Merger Agreement is attached hereto as Exhibit 2.1 and is incorporated herein by reference. The description of the Merger Agreement contained in the July 1 Form 8-K is qualified in its entirety by reference to the full text of the Merger Agreement.
